**OTHER BUSINESS**

1. Discussion to add requiring site/field directors at all GLCSL games. This has been tabled to the next meeting
2. There was a motion to add the following to the bylaws to Article V, Section 8. The motion was seconded and approved.
  1. Meetings of members shall be presided over by the President of the League. If the President is not present, the next highest-ranking officer shall preside (Vice-President, Secretary, or Treasurer, respectively). At least one League officer must be in attendance. No voting can take place without a quorum. Quorum for GLCSL is 60% of active club members. League officers are not included in quorum unless they are representing a club
3. Reminder that the adult volunteers in your club must be doing their SafeSport training
4. Referee classes are online. We are down referees. Each year there are about a 1000 referees that do not recertify and about 1000 new referees. As of now, there are only about 100 new referees.
