## **OTHER BUSINESS**

- 1. COVID Rules and Updates: Players ages 13-19 will need to be tested starting April 2 through April 19. Clubs need to enroll with the state that they will be participating in testing their players. Document the calls that you make trying to get tests
- 2. U17/19: It was decided that 60x40 was the smallest size field. Players will play 6v6. 40 minutes. Referee pay will be \$35/\$30/\$30
- 3. Discussion about talking about what clubs will have what age levels each season before the final turn in date. Could have club reps fill out a Google Sheet with what levels they will be submitting before the final turn in date so clubs will know if the only age levels
- 4. Motion to add the following to the bylaws. Motion was seconded and approved
  - 1. In order to coach a game, a coach must be rostered to a minimum of one team within Great Lakes Coed Soccer League and the club they are wishing to coach for the current season. If their name is not on the roster they are wishing to coach, they must present a Great Lakes Coed Soccer League roster with their name on it from the current season and a photo ID of themselves before being allowed to coach that team. Failure to show a current Great Lakes Coed Soccer League roster and photo ID will result in the coach not being able to coach.
- 5. Motion to approve an increase of fees starting the Fall 2021 season. The motion was seconded and approved. The fee structure would be as follows:
  - 1. New player \$16
  - 2. New Coach \$13
  - 3. Returning player \$4
  - Returning coach \$4
